Section 1: Getting Started

Thank you for purchasing the Primer AP-Code Date coder. The AP-Code allows you to add printed information to your labeled containers immediately after applying the label. The AP-Code can be installed on any Primera AP360e or AP362e Applicator regardless of manufacture date.

1A Choosing a Good Location

- ▶ Place the AP-Code in a location with adequate air circulation to prevent internal heat buildup.
- ▶ Do not place the AP-Code near heat sources such as radiators or air ducts or in a place subject to direct sunlight, excessive dust, mechanical vibration, or shock.
- Allow for adequate clearance above the AP-Code to accommodate the print head as you move the container arm up to its maximum height.
- Allow for 2" of addition clear on the right side of the AP360e/362e to allow for the touchscreen display and cable attachment.

1B Unpacking and Inspection

While unpacking your AP-Code, inspect the carton to ensure no damage has occurred during shipping. Make sure that all supplied accessories are included with your unit. The following items are included in the box:

- 1. Cartridge Carrier (Print Head)
- 2. 1x Solvent Ink Cartridge (53580)
- 3. Display Stand with attached drive roller sensor
- 4. Touch Screen
- 5. Micro USB Cable
- 6. HDMI Cable
- 7. Power jumper cable (5 mm barrel)




1C Assemble your Date Coder

1. Locate the Display Stand.



2. Place the display stand on the right side of the Applicator just above the AP360e/AP362e Logo Label. The magnets on the underside will attach it to the top of the cover. Make sure the thumbscrew tab on the left side of the display stand fits over the applicator frame.



3. Push the stand, so the bottom aligns with the top of the logo label.




4. Tighten the Thumb Screw




5. Locate the Roller Track Wheel attached to the display stand and remove the thumbscrew.




6. Position the track wheel to the pressure arm bar, so the thumbscrew hole is visible.




7. Push the track wheel to the right and tighten the thumbscrew.




8. The roller track wheel should be touching the Liner Drive Roller. If needed, push the roller track wheel down firmly to touch the Liner Driver Roller accordingly.



9. Locate the Cartridge Carrier.




10. Place the Cartridge Carrier on the Roll Pressure Arm. Turn the magnet so it faces the arm. The magnet is all you need to attach the cartridge carrier.




Roll Pressure Arm

11. The thumbscrew allows you to adjust the height and position of the print head along the Roll Pressure Arm. Once you have it where you want, tighten the thumbscrew.




12. Install the touchscreen display tablet. Orient the screen, so the power button and ports are on the right side.




13. Slide the Touchscreen into place on the display stand.



14. Connect the HDMI cable to the cartridge carrier (1) and the left side of the display stand (2).





15. Connect the power from the display stand to the Touchscreen




Power Button (Hold to Power off display)

16. Connect the micro USB cable to the Touchscreen and the back of the display stand.





17. Connect the Power jumper cable to either of the ports on the back of thdisplay stand. Connect the other side to the Applicator.



18. Use the power supply that came with your Applicator. Plug it into the remaining open port on the back of the Display Stand.



19. Connect the power supply to a power outlet and toggle the power switch.



1D Install the ink Cartridge

The AP-Code comes with one solvent-based ink cartridge, which will last for thousands of prints. If you need to replace the cartridge or clean the cartridge nozzles, use this procedure to remove and replace the cartridge.


- 1. Remove the cartridge from its packaging.
- 2. Separate the cartridge from the cartridge cap.



3. Keep the Cap And the foil bag to Store the Cartridge!



4. Angle the cartridge slightly (15 degrees) as you insert it into or remove it from the carrier.




5. When the cartridge is fully seated, lower the blue lever to lock it into place.

1E. IMPORTANT: Cartridge Storage

To prevent ink evaporation, when the cartridges is not being used, you should remove it from the printer, cap it using the included cartridge garage and store it in the zip locked foil bag that it came with. For best results, follow this procedure after use every day!




1 F Set your applicator to Run After Apply Mode

This mode, causes the container rollers continue to spin after every application allowing the print complete successfully especially if you have setup and text offset/time delay on your AP-Code. This is the default mode of the AP362e applicator and should automatically be enabled if you just purchased the applicator. If you have the AP360e, the applicator can only be set to Run After Apply Mode.

Instructions:

- 1. Turn off the applicator.
- 2. Press and hold the **Recall** button with the '+' key and turn on the applicator.




Note: The applicator can be in stop after apply mode if the **text offset is zero** and the label length is longer than the width of the code printed. Since the container will continue to spin while the label is being applied, a label longer than the printed code will ensure the code printing is not interrupted.


Section 2: How to use AP-Code

2A Tutorial: Create a Tag


- 1. Install your label roll and thread it through the Applicator as you normally would. Refer to the applicator <u>setup video</u>.
- 2. Ensure the container pressure arm is contacting the container with pressure. Usually you will need to remove the container first, lower the container pressure arm ½" and press the container in place. The pressure arm is springloaded. This allows the spring pressure to engage your container.
- 3. Once your container has been installed, use the thumbscrew to adjust the position of the print head/printing position. There should be approximately 1/8" (3mm) between the container and the printhead.



4. Move the container left to right or the Pressure Arm left to right to adjust the print position. You may need to change the orientation of your container to achieve some print positions. In the example above, to print on the bottom of the container, we would need to flip the container, so the top of the container is on the left.




5. Once the container is in the correct position, you are ready to create the tag. Touch Line 1 on the display. When you touch the screen, a keyboard will appear. Type the contents of your tag. In this case, type "Best By". Repeat the process for Line 2. Type the Best by date "12/03/23". Line 2 is optional.



6. You may also adjust text orientation by touching the Tt icon or adjust font size by grabbing the slider and dragging. If the font is too large, you can only print one line of text.


7. Touch Save Tag to save the text and attributes for future use.



8. We are now ready to apply a label and print our tag. Load a container and press the foot pedal.




9. The first time you apply a label and print, you will probably need to adjust the position text offset. Text offset adjusts the tag position around the circumference of the container. You can only move the tag in one direction. For example: to move the tag slightly to the right you increase the text offset just a little. If you want to move it to the left, you would increase the offset by a lot, so the text would move almost all the way around the container!



10. In this case, we would like to move the tag to the right, so it is directly on the back of the container relative to the position of the label. Use a paper roller or flexible tailor ruler to measure how far to move the tag.



11. Press "Text Offset" on the touch screen to enter the amount you want to move the tag. The maximum offset is 17".




Touch here to adjust Text Offset

12. Now, apply the label and print again. It's perfect!




2B Touch Screen Overview

Touch the gear icon to access system settings




Note on Test Print and Clean Print: Send these prints with a container in place and rolling. Prints are sent to the printhead immediately, but they are only intelligible if the container is in place and rolling.

2D Save and Load Tags


If you have several different containers with unique text and setting configurations, you can Save tags and load them again for future use. The text, font size, Orientation, and Text Offset will be saved along with the name you choose for the tag.

1. Touch Save Tag to save the text and attributes for future use.






2. To load the tag, press the Load Saved Tag button on the main screen.



2E Adjusting Print Position


There are three ways to adjust print position of the tag.

1. **Adjust the Container Position.** You can move the container left or right on the container rollers. You can also flip the orientation of the container. In the example below, in order to print on the bottom, the container would need to be in the opposite orientation.






2. **Adjust the Print Head Position.** You can adjust the print head position by moving the container pressure arm left or right. You have a limited range to move this if you would still like to use the container pressure arm to keep pressure on the container for optimal label application. If you move it too far to the left, the arm will no longer contact the container. In this case, it may be better to change the container's orientation (see #1).



3. **Adjust the Text Offset to change where the tag prints around the circumference.** You can only move the tag in one direction. For example: to move the tag slightly to the right, you increase the text offset just a little.




In this case, we would like to move the tag to the right, so it is directly on the back of the container relative to the position of the label.

Use a paper roller or flexible tailor ruler to measure how far to move the tag.



1. Press "Text Offset" on the touch screen to enter the amount you would like to move the tag. The maximum offset is 17".




2F Create Automated Expiration Dates

If your product has an expiration, best-by date, or manufacture date you would like printed on your container, you can use this feature to automate the process by adding a date offset from the current date, so you don't always have to change the expiration date every time you apply labels and add tags.

1. To enable this feature, press the menu icon in the upper left corner of the screen.



2. First, you will need to set the Current Date. This will be stored in the system as long as power is connected to the date coder. If power is removed, you will be prompted to enter the date again if you choose a tag that contains an auto-calculated date. **Note:** You can switch off the applicator without disconnecting power to the Date Coder.




3. Set the line you would like the automated date to appear.





Note: To print the current date, set the Offset to zero Days.

- 4. Choose the header from several premade options, or choose your own by selecting "Custom."
- 5. Set the date format.
- 6. Finally, set the offset, which is the number of days, months, weeks, or years from the current date you set previously. This will be the date that appears on the tag. **For example:** if the current date is 12-9-22 and you set the offset for three months, the date that appears on the tag will be 3-9-23.
- 7. Click Create.
- 8. If your tag has an automated date, you will see a calendar icon on the line with the automated date.




Section 3: Maintenance and Troubleshooting

3A Cartridge Cleaning – Nothing is Printing

Check <u>this article</u> for all troubleshooting steps. However, If you have not used the AP-CODE Date Coder for some time you may need to clean the nozzles.

1. Do not remove the cartridge for this procedure. Instead, the entire cartridge carrier can be rotated sideways for cleaning.




2. Use the provided alcohol pad or fold up a lint-free cloth several times and wet it with isopropyl alcohol. The ink nozzles are in a single row centered on the bottom of the cartridge; they are recessed slightly, so take care to clean them and not just the surrounding area. Press them into the pad until ink flows out, then wipe away any excess ink using the alcohol pad.



Alcohol Pad







Press and hold for 10 seconds.

Repeat until ink starts to flow.

3B Tag Removal

If you accidentally print in a location, you did not intend, you can remove the print entirely by using isopropyl alcohol to clean the print form the container. This works best on glass and plastic or metal.

3C Acceptable Print Surfaces

You may print on the following surfaces.

- Various Label Materials such as Genuine DTM Label Stock Materials, Polyester, BOPP, Vinyl or Paper Labels
- Glass
- Plastic
- Metal
